Any customer of the Village of Ceresco changing from one location to another shall make a new application and sign a new contract. The Village of Ceresco does not guarantee the delivery of utilities through its distribution system at any time, to any person, except when its utility distribution system and connections are in good working order and it has sufficient supply, equipment, and machinery to do so. The Village of Ceresco and its employees shall have access at all reasonable hours to premises in which utility service is being used to determine if it is being carried, distributed and used in the proper manner. Meters of the type designated by the Village of Ceresco Board of Trustees shall measure the water utility furnished customers of the Village of Ceresco. The rates to be charged for utility services shall be as the Village of Ceresco Board of Trustees shall prescribe by resolution or ordinance. In the event of non-payment of utility service, utility services may be disconnected in accordance with the Municipal Code and the policies of the Village of Ceresco. All applicants shall be required to make their utility deposit at the time of their application which may be held indefinitely by the Village of Ceresco to guarantee payment of any utility bill.
