Mark Rezac with Prague Insurance Agency was present to review the Village's insurance for 2023/2024. The commercial property values increased \$600,100.00 or 7%, making total property values \$8,104,200.00. The Commercial General Liability, Employment Practices Liability, Commercial Auto, Inland Marine and the Umbrella all have premium increases. Worker's Compensation has decreased. The total premium now includes a package discount. Terrorism was reviewed and the Board agreed to continue the coverage. The statement of values were reviewed. Discussion held. The skid loader attachments will be added.

Ruble moved to pay the insurance premium in the amount of \$55,699.00. Peterson seconded. Voting Yeas: Ruble, Peterson, Eggleston and Rupe. Nays: none. Motion carried.

Kelly Gentrup with Southeast Nebraska Development District was present to review services and programs available. She noted since Ceresco is not low to moderate income, a lot of Community Development Block grants are eliminated, but there may be other resources available. Rupe questioned funds for small businesses.
