Roland reviewed: 1) Started digging the new well today. 2) Drought - Well #5 has dropped about 10 feet. Still pumping 150,000 to 160,000 gallons of water a day. 3) Well #5 and #6 are both back in service after maintenance. 4) New valve has been put in at the wwtp. 5) Inventory for lead and copper has been turned in. 6) Water main replacement on Elm Street and replacing hydrants were discussed. Spearman will be contacted regarding rates and bonding. Lovell Excavating will be contacted for hydrant bids. 7) Johnson Service sewer maintenance quote.

AN ORDINANCE OF THE VILLAGE OF CERESCO, SAUNDERS COUNTY, NEBRASKA, TO ESTABLISH, PURSUANT TO SECTION 7-105 A TABLE OF RATES – WATER, PER MONTH, AND A TABLE OF RATES – SEWER, PER MONTH FOR ALL WATER AND SEWER UTILITY CONSUMERS OF THE VILLAGE OF CERESCO, NEBRASKA, AND SECTION 7-508 COMPOST SITE FEES.

WHEREUPON, Board member Peterson moved that said Ordinance 2024-7 be approved by its third reading as presented and its title agreed to. Board Member Ruble seconded this motion.

The Chair instructed the Clerk to call the roll for the vote thereon. The Clerk called the roll and the following was the vote on this motion. Yeas: Peterson, Ruble, Eggleston, and Rupe. Nays: none.

Ordinance 2024-8 was introduced by Chairperson Rupe and is set forth in full as follows, to wit: AN ORDINANCE OF THE VILLAGE OF CERESCO, SAUNDERS COUNTY, NEBRASKA, TO AMEND SECTION 6-103 OF THE MUNICIPAL CODE OF THE VILLAGE OF CERESCO, SAUNDERS COUNTY, NEBRASKA, THE VILLAGE BOARD OF TRUSTEES HAS ADOPTED A MUNICIPAL CODE, AS REVISED AND AMENDED FROM TIME TO TIME, TO PROVIDE FOR RULES AND REGULATIONS WITHIN THE MUNICIPALITY TO PROMOTE THE HEALTH AND WELL-BEING OF IT'S INHABITANTS; TO PROVIDE THAT THE CHAIR OF THE BOARD OF TRUSTEES, AND THE APPROPRIATE DEPARTMENT, WHETHER ONE OR MORE, OF THE VILLAGE OF CERESCO, NEBRASKA, ARE AUTHORIZED AND DIRECTED TO IMPLEMENT THIS ORDINANCE: TO PROVIDE FOR THE SEVERABILITY OF ANY SECTION, CLAUSE, PROVISION OR PORTION FOUND UNCONSTITUTIONAL OR INVALID; TO REPEAL ALL ORDINANCES IN CONFLICT HEREWITH; TO PROVIDE THAT THIS ORDINANCE SHALL BE PUBLISHED WITHIN THE FIRST FIFTEEN DAYS AFTER ITS PASSAGE AND APPROVAL EITHER IN PAMPHLET FORM OR BY POSTING IN THREE PUBLIC PLACES IN THE VILLAGE OF CERESCO, NEBRASKA, AND SHALL BE IN FULL FORCE AND TAKE EFFECT FROM AND AFTER ITS PASSAGE, APPROVAL AS PROVIDED BY LAW AND AS PROVIDED HEREIN; AND TO PROVIDE THAT THE PROVISIONS OF THIS ORDINANCE SHALL BE MADE A PART OF THE MUNICIPAL CODE OF THE VILLAGE OF CERESCO, NEBRASKA, AND MAY BE RENUMBERED TO ACCOMPLISH SUCH INTENTION.

WHEREAS, Chapter 6 of the Municipal Code of the Village of Ceresco, Nebraska, pertains to Public Ways and Properties of the Village of Ceresco, Nebraska, and,

WHEREAS, Ceresco Post Office is at capacity and is unable to provide post office boxes to residents of new subdivisions and, there is a need to provide mail service to all residents of the Village of Ceresco, Nebraska, and,

THEREFORE, adding with the exception of new subdivisions to Chapter 6 Section 103: Rural Mail Boxes Prohibited with the exception of new subdivisions, and,

WHEREAS, the Board of Trustees of the Village of Ceresco, Nebraska, deem it in the best interest of the citizens of the Village of Ceresco, Nebraska, that said aforenoted change be made to provide mail service to all residents in the Village of Ceresco, Nebraska,

NOW, THEREFORE, BE IT ORDAINED BY THE CHAIR AND BOARD OF TRUSTEES OF THE VILLAGE OF CERESCO, NEBRASKA, AS FOLLOWS:

Section 1. That the findings herein and above made should be and are hereby made a part of this Ordinance as fully as if set out at length herein.

Section 2. That Chapter 6 of the Municipal Code of the Village of Ceresco, Nebraska, be amended as follows:

SECTION 6 – 103: RURAL MAIL BOXES PROHIBITED <u>WITH THE EXCEPTION OF NEW SUBDIVISIONS</u>

It shall hereafter be unlawful for any person to erect, maintain, or allow to exist a rural mail box upon public property, including the street and sidewalk space, within the village, with the exception of new subdivisions. Developers of new subdivisions must install Cluster Box Units at the direction of the Post Master.

Section 3. That the Chair of the Board of Trustees and the appropriate Department of the Village of Ceresco, Nebraska, are hereby authorized and directed to implement this Ordinance.

Section 4. That should any section, paragraph, sentence or word of this Ordinance hereby adopted be declared for any reason to be invalid, it is the intent of the Board of Trustees of the Village of Ceresco, Nebraska, that it would have passed all other portions of this Ordinance independent of the elimination herefrom of any such portion as may be declared invalid.

Section 5. That all Ordinances and parts of Ordinances passed and approved prior to the passage, approval, and publication of this Ordinance, in conflict herewith, are hereby repealed.

Section 6. That this Ordinance shall be published within the first fifteen days after its passage and approval, either in pamphlet form or by posting in three public places in the Village of Ceresco, Nebraska, and shall be in full force and take effect on the fifteenth day from and after its passage, approval, and publication as provided herein.

Section 7. That it is the intention of the Board of Trustees of the Village of Ceresco, Nebraska, and is hereby ordained that the provisions of this Ordinance shall amend the Municipal Code of the Village of Ceresco, Nebraska, and the Sections of this Ordinance may be renumbered to accomplish such intention.

The Chair thereupon read the aforesaid Ordinance No. 2024-8 of the Village of Ceresco by title.

WHEREUPON, Chairperson Rupe moved that said Ordinance 2024-8 be approved on its first reading and its title agreed to. Board Member Eggleston seconded this motion.

Ordinance 2024-9 AN ORDINANCE TO AMEND THE WAGES AND SALARIES OF CERTAIN OFFICERS, APPOINTEES, AND EMPLOYEES OF THE VILLAGE OF CERESCO, NEBRASKA was tabled to a special meeting.
